Incorporated on 27.01.1953, Hindustan Prefab Limited (HPL) is more than six decades experienced a wholly owned Central Public Sector Enterprise under administrative control of Ministry of Housing & Urban Poverty Alleviation. Its registered office is situated at Jangpura, New Delhi - 110014.

BACKGROUND

Originally, Hindustan Prefab Limited was set up in 1948 as a Department of Govt. of India, titled as 'Govt. Housing Factory' under the administrative control of the then Ministry of Production. It was a brainchild of our first visionary Prime Minister, Pandit Jawaharlal Nehru with the prime objective of providing housing solutions to the Internally Displaced People from Pakistan. In 1952, it was converted from Department into a factory named as 'Hindustan Housing Factory Limited' and was registered as a Company on 27.01.1953. It became a CPSE on 16.08.1955 and its name was changed to 'Hindustan Prefab Limited' on 09.03.1978. It has come off age and earned its name and fame by pioneering the PRC Railway Sleepers.

The main objectives of the Company are set out in the Memorandum and Articles of Association. Besides the Vision, Mission and Objectives of the company are as under:
